आपके प्रार्थना पत्र यूआईडी नं०-80760023 दिनांक 31.07.2024 के द्वारा THE INDIAN ACADEMY, JOGIWALA MUSSOORIE BY PASS GARHWALI COLONY, DOBHAL CHOWK NEHRUGRAM, जनपद देहरादून की अग्निशमन सुरक्षा व्यवस्था का निरीक्षण अग्निशमन अधिकारी देहरादून द्वारा किया गया। अग्निशमन अधिकारी देहरादून की निरीक्षण आख्या दिनांक 06.08.2024 के अनुसार स्थापित अग्निशमन यंत्र कार्यशील दशा में है। उपकरणों का निर्धारित परीक्षण शुल्क राजकोष में जमा करा दिया गया है।

निर्देशित किया जाता है कि अग्निशमन उपकरणों को सदैव कार्यशील दशा में रखेंगे। स्कूल भवन के विस्तार/अतिरिक्त किसी भी प्रकार का कोई परिवर्तन किया जाता है तो अग्नि सुरक्षा प्रमाण पत्र नये सिरे से लिया जाना अनिवार्य है, साथ ही अग्नि सुरक्षा अनापत्ति प्रमाण पत्र प्राप्त करने के उपरान्त संस्थान को प्रत्येक 06 माह में भवन अथवा परिसर में अग्नि सुरक्षा व्यवस्था एवं उपकरणों की स्थिति संतोषजनक एवं कार्यशील होने का स्व-घोषणा पत्र/**Self Audit Report** इस कार्यालय को ऑन लाईन/ऑफ लाईन माध्यम से प्रस्तुत करना अनिवार्य होगा।

अतः THE INDIAN ACADEMY, JOGIWALA MUSSOORIE BY PASS GARHWALI COLONY, DOBHAL CHOWK NEHRUGRAM, जनपद देहरादून को अग्निशमन सुरक्षा सम्बन्धी अनापत्ति प्रमाण पत्र 03 वर्ष हेतु दिनांक 13 अगस्त 2024 से 12 अगस्त 2027 तक इस आधार पर प्रदान किया जाता है कि निम्न शर्तों का पालन किया जाना आवश्यक होगा:-

1. प्रश्नगत भवन में उपलब्ध अग्निशमन सुरक्षा व्यवस्था के अतिरिक्त बेसमेन्ट में मानकानुसार निश्चित दूरी पर ऑटोमेटिक स्प्रिंकलर सिस्टम तथा बेसमेन्ट से धुँए के निकास हेतु स्मोक एक्सट्रैक्शन सिस्टम एवं फ्रेश एयर इण्डक्शन यूनिट का प्राविधान 60 दिवस (02 माह) के भीतर करवाकर इस कार्यालय को अवगत कराना आवश्यक होगा, अन्यथा अग्निशमन सुरक्षा सम्बन्धी अनापत्ति प्रमाण पत्र प्रभावी नहीं रहेगा और स्वतः ही अनापत्ति प्रमाण पत्र निरस्त समझा जाएगा।
2. बेसमेन्ट को रिहायशी उपयोग में नहीं लाया जायेगा तथा बेसमेन्ट में शौचालय या रसोईघर का निर्माण अनुमत्य नहीं होगा।
3. प्रश्नगत भवन ब्लॉक-01 (भूतल एवं प्रथम तल), ब्लॉक-02 (भूतल एवं अग्रेत्तर दो तल) तथा ब्लॉक-03 (बेसमेन्ट, भूतल एवं अग्रेत्तर दो तल) में निर्मित है। यदि भवन का उपयोग अन्य प्रयोजन (हॉस्पिटल/नर्सिंग होम/होटल/गेस्ट हाउस आदि) हेतु किया जाता है तो अग्निशमन सुरक्षा सम्बन्धी अनापत्ति प्रमाण पत्र प्रभावी नहीं रहेगा और स्वतः ही अनापत्ति प्रमाण पत्र निरस्त समझा जाएगा।
4. सभी बाहर निकलने या बचाव के रास्ते, सैट बैक तथा सीढ़ियाँ सदैव अवरोध मुक्त रखी जाए। इमरजेन्सी साईन एकिजट, पावर बैक अप के साथ रहेगी।
5. आपके शैक्षणिक भवन के सभी कर्मचारियों एवं विद्यार्थियों को उपलब्ध अग्निशमन यंत्रों के संचालन तथा सुरक्षित निष्क्रमण प्रक्रिया (Evacuation) का ज्ञान होना आवश्यक है। समय-समय पर स्थापित अग्निशमन उपकरणों/यंत्रों का निरीक्षण/परीक्षण करते हुए सदैव कार्यशील रखेंगे, तथा समय-समय पर मॉक ड्रिल करते रहेंगे।
6. सभी अग्निशमन यंत्रों को कार्यशील दशा में रखने की जिम्मेदारी प्रधानाचार्य/प्रबन्धक की होगी। अतिरिक्त अग्निशमन यंत्रों की स्थापना का अर्थ यह नहीं लगाया जाए कि अग्निकाण्ड की घटना नहीं हो सकती। अतः स्वामी/प्रबन्धक को अग्नि रोधक उपाय सदैव करते रहना चाहिए।
7. शैक्षणिक भवन के विद्युत यंत्रों की स्थापना, वैंटीलेशन, स्ट्रक्चर, स्टेबिलिटी, सैट बैक एरिया व निर्माण, Land Use Change में बदलाव आदि का सत्यापन सम्बन्धित अधिकारी से कराया जाए।
8. शैक्षणिक भवन के विस्तार/अतिरिक्त निर्माण करने से पूर्व इस कार्यालय से मानचित्र अनुमोदित करवाकर मानको के अनुसार अतिरिक्त अग्निशमन व्यवस्था की जानी आवश्यक होगी।
9. शैक्षणिक भवन में संचालित लैब (कैमेस्ट्री, कम्प्यूटर आदि) में सीओ2 फायर एक्सटिंग्यूशर का प्राविधान किया जाना आवश्यक है।

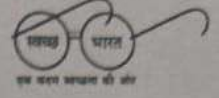


